

**VILLAGE OF VOLO
ORDINANCE
(An Ordinance Adopting Certain Codes
as the Building Codes of the Village of Volo)**

BE IT ORDAINED by the President and Board of Trustees of the Village of Volo that the following list of codes are hereby adopted and amended as part of the Village Building Code for the control of building and structures as therein provided in each code. Each and all of the regulations, provisions, penalties, conditions and terms obtained in each code described below are hereby referred to, adopted and made a part hereof as if fully set forth herein:

- A. International Building Code 2003 Edition, with the exception of those sections pertaining to Seismic Zones and Arc Fault Prevention;
- B. International Mechanical Code 2003 Edition;
- C. International Fuel Gas Code 2003 edition;
- D. International Residential Code 2003 Edition;
- E. International Fire Code 2003 Edition;
- F. International Property Maintenance Code 2003 Edition;
- G. International Energy Conservation Code 2003 Edition;
- H. National Electric Code 2002 Edition; and
- I. Illinois Plumbing Code 2004

Further, provided that:

1. All words contained in the codes which refer to the municipality or other words of similar meaning shall mean the Village of Volo.
2. The words "municipal authority" or "government authority" or words of similar meaning shall, for purposes of this subsection, mean the President and Board of Trustees.
3. The words "enforcing officer," "hearing officer," "building inspector," "building official" or other words of similar meaning shall refer to the person or entity designated by the President and Board of Trustees to act in that capacity.

4. The National Electric Code is amended to require that all wiring be at a minimum in electro metallic tubing (EMT).

All other ordinances in conflict with this ordinance are hereby repealed.

This Ordinance shall be in full force and effect upon its passage and approval as provided by law. This Ordinance shall be published in pamphlet form.
