Several members of the Fox Lake Fire Department attended the Safety Committee to discuss the parking situation in Terra Springs Subdivision. According to a letter from Mr. Richard E. Hoehne, Captain/Assistant Chief Engineer, it is the opinion of the Fox Lake Fire Department that no on street parking should be allowed in the Terra Springs Subdivision.

Mr. Richard Eckenstahler, Chief of Operations at the Lake County Sheriff's Department, addressed the Safety Committee regarding the fines received from Lake County for violations occurring within the boundaries of Volo. The deputies who service the Village are answering more diversified calls than just traffic violations. Since the number of residents has increased, the type of calls for service has changed drastically.

Trustee Evans reported that he had been researching the Reverse 911 System and had found that the system is not economically feasible for the Village at this time.

1. **Public Safety Committee**

1. The Fox Lake Fire Department had gone to Terra Springs to investigate the parking situation on the streets, but the Village has not received any results from the Fire Department. It was suggested that Village Administrator Ken Buchardt contact the Fire Department and request a report.
2. Village Attorney Nancy Harbottle suggested the Safety Committee investigate what the reverse 911 system is and how it functions.

2. **Finance Committee**

President Russell reported that he and Village Administrator Ken Buchardt and the Village Staff have been meeting to discuss re-capture fees for the sewer and water for the developing subdivisions.
